Department Order No. 15, Series 2015-2016

- 1. The Sesquicentennial of the Grand Army of the Republic (G.A.R.) is April 6th, 2016. It was on April 6th, 1866 that the G.A.R. was formed by Benjamin F. Stephenson and membership was limited to honorably discharged veterans of the Union Army, Navy, Marine Corps or the Revenue Cutter Service who had served between April 12, 1861 and April 9, 1865.
 - a. To honor the memory and service of the veterans of the G.A.R., I hereby request that each camp in the Department of New York arrange a bell ringing ceremony in their Camp area. Arrangements with a municipal building, church or fire company should be made to celebrate the Sesquicentennial of the founding of the Grand Army of the Republic. The bell ringing should be coordinated across New York State at Twelve Noon on Saturday, April 9th and the bell should be rung 15 times in honor of the 150th anniversary of the founding of the G.A.R. The bell ringing should be attended by Camp representatives and, preferably, a color guard.
 - b. Before each Camp's bell ringing ceremony a suitable press release should be made to the local media to announce the brief ceremony to be called "Bells Across New York for the G.A.R." The event should be documented in order to memorialize this Sesquicentennial celebration unique to our Order.
- 2. Another part of the Sesquicentennial activities will be the registration of GAR and other monuments and memorials by the Camps in the Department. It is hereby ordered that each Camp do the following things to assist our Department in this effort:
 - a. Each Camp is to take the time to locate three GAR monuments in their respective Camp territory and submit the information to the Department using National Form CWM_61. These forms will be forwarded to our National organization for incorporation into the list of registered monuments.

- b. It is requested that along with CWM_61 that the Camp submit photographs of each monument and a brief but detailed description of its history to the Department. Form CWM_61 helps in this task.
- c. The information submitted will be assembled into a book of monuments, self-published by the Department, to honor the members of the GAR during this Sesquicentennial. Each Camp will be recognized for their contribution.
- d. Every camp is to submit their three monuments to the Dept. Civil War Memorials Officer, Bro. David Dziewulski, PCC at dmdeezee@nycap.rr.com or if you do not have access to email you may submit in writing to:

Revocation was granted by National General Order No. 23 of Series 2014-2015 on June 2, 2015 as both
camps were under suspension for failing to file reports and submit per capita dues.

The Camps were the following:

- a. The General Alexander S. Diven Camp No. 77 of Elmira, NY which has been suspended for not filing their reports on time and for not paying their per capita dues since May 15, 2015 per Department Order No. 2 of Series 2015-2016. The Camp decided to voluntarily surrender its charter on May 20, 2015 and also sent the Camp properties to the Department in full compliance.
- b. The Daniel E. Sickles Camp No. 3 of White Plains, NY which has been suspended for not filing their reports on time and for not paying their per capita dues since being suspended on May 21, 2014 per Department Order No. 2 of Series 2013-2014. The charter and properties of the camp have yet to be delivered to the Department.
- 2. In accordance with National Regulations, Chapter I, Article I, Section 5, the former officers and members of the above-mentioned Daniel E. Sickles Camp No. 3 of White Plains, NY are reminded that all Camp property and money shall be turned over to the Department Commander, or to his duly authorized representative, and become the property of the Department of New York.

- I. Purpose, Objective and Scope of the MoU The focus of this understanding is the storage and maintenance the charters, documents, art, photographs (ephemera) and other items (property) of the Department of NY, Sons of Union Veterans of the Civil War (Department) by the Friends of the New York State Military Museum (Friends) on behalf of the New York State Military Museum (NYSMM).
- II. Background, Situation, and Status of the three Parties The Department is a non-profit 501(c)4 organization that strives to preserve the memory and monuments of the men who served in the Union Military, 1861-1865 particularly in New York State. The Friends of the New York State Military Museum: The mission of Friends is to be a support to the New York State Military Museum, to aid in fund raising for exhibits and displays, as well as assisting in drawing attention to the museum through programs, lectures and events. As the board of trustees, we are the elected board which helps direct the membership to facilitate the support mission of the non profit group.
- III. Review Date of the MoU & Changing Articles Beginning in 2016 this MoU may be reviewed for revision at the request of any individual party. When a review is requested it will occur at a location (e.g. at the Military Museum in Saratoga Springs) and on a date mutually agreeable to all parties. Any of these articles can be changed at the request of either party, at any time and upon the agreement of the respective parties. The Friends and the Department will then meet in person or via email and discuss changes and finalize an agreement about the changes.
- IV. Agreement Details The Friends will shelve and store all properly archived ephemera and property from the archives/collection of the Department in a secure and heated storage room, provided that:
- a) Ephemera be placed in individual archival folders and then be stored & labeled in appropriate archival boxes;
- b) Property be stored in an appropriate closed container;
- All materials needed for the proper storage of ephemera or property will be provided by the Department;

- d) The ephemera of the Department, any defunct SUVCW Camps and antecedent organizations such as the Grand Army of the Republic (or GAR) including minutes and notes be expeditiously reviewed for disposition within eighteen (18) months of the signing of this MoU. Saved ephemera will then be archived while unnecessary ephemera/property (items) will be removed from the archive site or offered for sale or storage at an alternate site (historical society, museum or similar location).
- IV. Compensation Details In the interest of continued preservation, any items of the collection that are deemed unnecessary by the Department as described in section IV.(c) will be offered to the Museum collection if they are deemed to have some historic value and they can contribute to the overall collection or mission of the NYSMM.
- No party will be directly compensated without prior mutual agreement on the nature of the compensation. Unless otherwise agreed, all funds generated from the sale of any items must be accounted for in writing by and/or to both parties. Unless otherwise agreed, any transfer of items to the Friends will be accounted for in writing by the Department.
- The Friends accepts no responsibility for the condition of the collection which may be due to any loss by fire, water damage, insect/vermin destruction or other *force majeure* or by theft.
- Terms of Agreement –[1] This understanding becomes active upon signing. Department Order No. 24, Series 2015-2016

By the authority vested in me as Commander of the Department of New York,

- 1. I hereby recognize the Sesquicentennial of the founding of the Grand Army of the Republic (G.A.R.). It was 150 years ago today, on April 6, 1866, that the G.A.R. was formed by Benjamin F. Stephenson with membership was limited to honorably discharged veterans of the Union Army, Navy, Marine Corps or the Revenue Cutter Service who had served between April 12, 1861 and April 9, 1865.
 - a. The national GAR was founded on April 6, 1866 because all the founding members took part in the Battle of Shiloh.
 - b. The first post of the New York Department, GAR, was O'Rorke Post #1 of Rochester chartered on October 8, 1866. Over 600 posts were chartered until one of the last ones was McDowell Post #672 in Elmira in May of 1915.
 - c. The New York Department was founded in Albany on April 3, 1867. In the beginning, department commanders tended to be officers of the Union army. The first Dept. Commander was Col. James B. McKean of Saratoga Springs.
 - d. National Encampments of the G.A.R. were held in Albany, 1879; Buffalo, 1897; Saratoga Springs, 1907; Rochester, 1911 and Rochester, 1934.
 - e. The 82nd and last department encampment of the GAR was held June 11, 1948 in Rochester with James A Hard, Dept. Commander, a veteran of Co.F, 32nd NYSV, as the only member to attend. Past Commander-in-Chief Robert Rownd of Ripley could not attend. The City of Rochester made this last meeting of the GAR a grand celebration. James Hard died at age 111 on March 12, 1953.

I hereby request that all Brothers and Camps in the Department participate this month of April in commemorations, memorials, services and events held for the Sesquicentennial of the founding of the G.A.R.

The deeds and accomplishments of the Grand Army of the Republic will remain in the history of the Empire State because of its members devotion to is motto of "Fraternity, Charity and Loyalty".
