# Camp Reports

2013 Annual Report: Augustus V. Ellis Camp 124, Sons of Union Veterans of the Civil War

While the Augustus Ellis Camp 124 participated in various activities and events during 2013, a large amount of time was devoted to planning for Sesquicentennial events and activities in 2014 that required advance preparations. These included a biennial commemoration event for the Shohola Train Wreck Disaster that occurred in 1864 in the Shohola, PA/ Barryville, NY area. Plans also began for the creation of a memorial plaque honoring Civil War soldiers of the City of Warwick, NY. and dedication ceremony. The Camp was involved during 2013 with planning the installation of permanent lighting for the statue in Goshen, NY called the Bradley Monument, memorializing the members of the 124<sup>th</sup> New York State Volunteers. An additional event planned during the 2013 calendar year, was a ceremony at Mt. Moor Cemetery in West Nyack, NY, which would honor the soldiers of the United States Colored Troops, who are buried there.

While planning these various events, the Camp participated in an Annual Civil War event at Museum Village, in Monroe, NY and held commemorative services at the grave of a fallen Union soldier buried in the Walkill Cemetery, in Walkill, NY., Lt. David C. Lloyd – 87th NYVI.

A significant amount of time was devoted in 2013 to research and remedies for an unfortunate lapse in the responsibility incumbent on one of our primary officers, that involved both fiscal and record-keeping duties. The confusion and delays caused by this incident had serious negative effects and prevented a more active Camp schedule. The Camp, nevertheless, was able to carry on the activities mentioned above, as well as conduct our annual scholarship contest, awarding a scholarship to a high school student who submitted the best essay on a local Civil War theme out of 24 applicants. A number of Eagle Scout recipients were presented with certificates of recognition from our organization.

A special remembrance event was conducted in July, at the grave of General J. H.H. Ward in Monroe, NY. A project to restore Civil War gravestones at a cemetery in New Windsor, NY., was initiated and brothers participated in restoration work there. Our Graves Registration Officer continued his fine work in identifying the burial sites of many Union veterans, especially those of the 124th NYVI.

In the face of some troubling difficulties, the Camp carried on and had a successful and productive year. With a new slate of officers and a busy schedule planned for 2014, we look forward to continued success.

Dear Mr. Secretary,

I beg to report on the activities, experiences, and duties that have marked the year since the passing of the last annual encampment. Homer Searle Camp #114 had an eventful year, and we continue to do our utmost to mark the occasion of the sesquicentennial of the Civil War in which the men we honor fought as well as seeing to the regular business that keeps our camp in good standing with the community and the order.

In June of last year we returned to Peterboro, New York, the location of the Gerrit Smith Land Office and National Abolition Hall of Fame to participate in the annual Civil War Days. We pitched our tent and stayed for both days. There we spoke with the public about the formation of the Sons of Union Veterans and did our utmost to bring our camp and the order at large to the attention of prospective new members.

In July we set up our display at the Madison County Fair in Brookfield, New York. The attendance at the fair in 2013 was not what it had been in other years, and our location there was not conductive to our meeting many people (fortunately, this changed in 2014, as will be reported next year), but we did our utmost, and our booth took second place in its category, coming in second only to the display of our associated order, the Daughters of Union Veterans.

In August we held our annual picnic in Bridgewater, New York. All had a good time, and once again we were fortunate to share the occasion with the Daughters of Union Veterans. A program on General Slocum followed the meal.

In October, the camp was privileged to take part in one of the most solemn ceremonies that the Sons of Union Veterans observe when we travelled to Watertown, New York to help dedicate the tombstone of one of the soldiers who we remember and honor. Private Asa Forbes, from whom one of our camp members, Chad Miller, is descended, never had a tombstone to mark his grave, a situation which we are glad to report has been rectified. We were honored to be able to join with our bothers from French Camp #17, the Daughters, and the Copenhagen Legion Post in delivering this long overdue tribute to Private Forbes.

When November came we had our annual elections. I was honored to be re-elected to my post as camp commander, and was also very happy that the newer members of our camp also found positions alongside those who continue in their commitment to the camp and order. Earlier in November we joined with the Daughters as they dedicated a New York state historical marker dedicated to

the life of Myrtilla Miner, abolitionist and civil rights activist from North Brookfield, New York.

December saw us once again fortunate to join with the Julia Hibbart Tent #71 of the Daughters for our holiday get-together. I personally provided a program that evening entitled 1863 in Review: The Year the Tide Turned. The year 2013 ended on that high note, and we were able to look back at what we had accomplished with pride.

At our January meeting we installed our new officers, and I personally began my new term as camp commander. Of immediate concern was the planning of our annual sesquicentennial forum. We had provided this forum each year for the previous three years, and we had experienced quite a bit of success with it.

In April of 2014, we held the forum at our meeting place in Bridgewater, New York. We had a small but spirited crowd, and were treated to four speakers and the Crooked Stovepipe Band who sang a wide selection of period songs and provided the story behind each piece.

The Homer Searle Camp #114 had a very productive year between the two annual encampments, and we have been active since the last. Our numbers remain steady, but our hope and focus has been on increasing these whenever possible. We look to the year ahead in the hope that we shall ever be able to represent the men who risked and gave their all that our Union could be persevered, and hope that upon our meeting in the fields beyond we can greet them with dignity and pride.

Members of the Camp have also played several parts in an original play based on life in the area during the Civil War. The grave of Private Ehil, the last Civil War survivor in Tompkins County, was also rededicated in the cemetery in Trumansburg, New York.
