Dziewulski, PCC read his report- General Thomas monument project work on monument has been 8 years on going, branches and tree removal, signage placed, has since been conducted, limited edition pens of tree branches presented at "Evening of the Earl" 20 pens made and with 18 fundraised raised well over \$1,000, the 2 first pens will be auctioned off separate. The final project of the rejuvenation of the recasting of the iron wrought fence, will cost \$12,000 to recast. Albany Steel has covered that remaining cost, with other funds coming from private donations. Thank you for your support if you bought a stamp cachet, or challenge coin. There will be ongoing maintenance to continue the work at the lot with the remaining funds. The project was declared "essentially done".

The New York State Civil War Memorials Database with Access has been recovered from Access, using Google Earth getting exact GIS coordinates and get to camps to finish up Form 61's.

Questions from report were read:

- 1. Should the monument information from the old Department website be reconstituted on the new Department website. If so, what form should it take? Are photographs too ponderous for the Department website?
- 2. Should the information be combined with the Access database that has been recovered and submitted piece-by-piece to the National database?
- 3. Is it worthwhile to trace the loss of the Access database and determine why New York data were never properly included in the National database?
- 4. What, if anything, can be done to simplify the monument submission process at the Department and National level? Can a simple online form be used on the Department website to get the overall process re-started?

Commended predecessor Brother Robert "Bob" M. Paul, PCC in maintaining the old department website all of these years and continuing to do so for a good portion of this year while I was working to move the site to a new platform.

The state of New York Department of Parks, Recreation, Historic Preservation and New York State DMNA has dismantled the New York State battleflag preservation project and ability to make donations for project are no more. Close to 75% batteflags remaining to be conserved, 472 flags need to be conserved. See Full attached report with sample letters.

#### -ACTIONS-COMMITTEE ON CONSTITUTION

- 1. General Order No. 7 Constitution Amendment Change Ratification for Article 4, Section 2B of the National Constitution to delete the words "the last proceeding". Recommendation to accept, PASSED Unanimously by vote.
- 2. Bro. Duffy proposed that the graves recognition award proposal to be presented to the individual who registers the most graves for the National Organization, Recommendation of amendment by PDC Albanese, amended to read as proposed that "The graves registration recognition award is to be presented to the individual that registers the most graves with the national graves registration officer". Bro. Swartwout seconded with a friendly amendment agreement by Bro. Duffy, PASSED unanimously by vote.
- 3. Proposal by Bro. Duffy that Article 11, Section 4 first paragraph of the Department ByLaws be deleted, Recommendation of amendment by PDC Albanese with a friendly amendment agreement by Bro. Duffy, PASSED unanimously by vote.
- 4. Proposal by Bro. Duffy that a new Article on Camps with second signatories be required on all accounts, safe deposit boxes. The opinion of the Committee is that the Department does not have the authority to order the camps to do anything beyond the regulations require us to do. The committee moves that the proposal be rejected. Friendly amendment by Bro. Duffy withdraws the proposal from ByLaws for the Department and that the Proposer requests this of the National Council of Administration from the Department.
- 5. Bro. Duffy proposed the Headstones Monuments Placement Recognition Award, The Committee does not see the need to have another award and moves that the proposal be rejected. Motion was seconded and REJECTED by vote.
- 6. Bro. Duffy proposed to place all of the Recipients; Individuals, Camps of all Department awards for the last 10 years be placed on the Department website as well as the calendar year be specified for awards. The Committee ruled that there is no specific language for placement and that the language is not in proper form and moves to reject the proposal. The motion was REJECTED by vote.
- 7. Bro. Duffy's Proposal of 11 Changes to the General Regulations Forms needs to be studied in more detailed and better explained, the Committee had trouble understanding, were DEFERRED to the Legislation Committee to be reviewed and reported on at the next Department encampment.
- 8. Proposal by PDC Albanese on amendment on duties of Assistant Secretary in Section 8, Article VII "Headquarters and Officers" in Department By-Laws by adding an additional paragraph prior to the existing paragraph in said section to read as

follows: "The Department Commander shall, in consultation with the Department Secretary, also appoint an Assistant Department Secretary who shall be responsible for preparing the Encampment Proceedings which, upon review and approval of the Department Secretary, shall be posted on the Department website in accordance with these bylaws and shall further assist the Department Secretary Department Council in such other ways as determined by said Department Secretary." Motion to waive the 60-day review and the motion itself was passed. The committee moves to approve the proposal, and proposal is seconded by Bro. Wheeler, PCinC, all were in favor, proposal PASSED.



> General Order #7 Series 2018-2019 5 December 2018



1. At the 137st National Encampment of the Sons of Union Veterans meeting in Framingham, Massachusetts, in August, 2018, at which a quorum was present throughout, and the required majority of such delegates voted in favor to amend Article V, Section 2 b of the National Constitution of the Sons of Union Veterans of the Civil War as follows:

Article V, Section 2b. If the Commander-in-Chief is of the opinion that an action of the last proceeding any National Encampment is in violation of or in conflict with our Congressional Charter, and/or the Constitution, and/or National Regulations, and/or United States Law, and/or any State's Law, he may propose such General Order(s) to delay implementation of such action or suspend such action if previously implemented, until such time as the violation or conflict can be corrected. A two-thirds majority vote of the Council of Administration is required to support the proposed General Order authorizing the Commander-in-Chief to proceed, the Commander-in-Chief abstaining from participating in such vote and the Senior Vice Commander-in-Chief may only vote to break a tie. Such presentation and vote may be taken by electronic means of communication. The Commander-in-Chief must propose a resolution to the conflict by the next National Encampment.

NOTE: The paragraph as presented contains the current language of the Constitution. The stricken wording on line two of the paragraph is the wording elimination approved by the National Encampment with the insertion of the word "any" in its place, (herein inserted in italics). In voting to approve or reject the change, please read the paragraph with the indicated deletions and the insertion indicated.

FURTHER NOTE: This proposal clarifies the Commander-in-Chief's authority to take action to suspend or delay the implementation of an action taken by any National Encampment rather than just the last National Encampment, and includes State Laws as well as United States Laws. The process for taking such action by the Commander-in-Chief remains the same.

2. As contained in Article IX of the Constitution, this amendment cannot be effected until favorably acted upon and ratified by at least by 50% of the Departments. Departments of the SUVCW are hereby directed to conduct a vote to ratify at their 2019 Department Encampments. The National Secretary is directed to provide instructions to Department Commanders on how to conduct and report the results of this vote.

#### **ARTICLE VII "Headquarters and Officers"**

**IT IS PROPOSED** that the Bylaws of the Department of New York, Sons of Union Veterans of the Civil War be amended as follows:

That section (8) Article VII be amended by adding an additional paragraph prior to the existing paragraph in said section to read as follows:

"The Department Commander shall, in consultation with the Department Secretary, also appoint an Assistant Department Secretary who shall be responsible for preparing the Encampment Proceedings which, upon review and approval of the Department Secretary, shall be posted on the Department website in accordance with these bylaws and shall further assist the Department Secretary Department Council in such other ways as determined by said Department Secretary."

#### Said section will then read:

Section 8. The Department Commander shall, in consultation with the Department Secretary, also appoint an Assistant Department Secretary who shall be responsible for preparing the Encampment Proceedings which, upon review and approval of the Department Secretary, shall be posted on the Department website in accordance with these bylaws and shall further assist the Department Secretary Department Council in such other ways as determined by said Department Secretary.

In addition to those outlined in the National Constitution and Regulations, the Officers of the Department of New York may include an Eagle Scout Recognition Officer, Archivist, Signals Officer, Guide, Guard, Musician, Color-Bearer, Webmaster, Veterans Home Visitation Officer, Adjutant to the GAR Highway Officer and JROTC Liaison Officer.

**PURPOSE:** The position of Department Secretary is one of the most burdensome in terms of paperwork in the Department. The Secretary must not only keep track of deadlines for the camps to file reports so that the Department can file reports but also has the burden of compiling the and submitted the Department Annual Report. Much of this includes contacting camps and sending them reminders. In addition, the Department Secretary has to take the minutes of the Department Encampment at and around the same time he is trying to secure camp annual reports so that he can prepare the Department Annual report. Finally, the Department Secretary must prepare the proceedings of the Encampment which is extremely time consuming and has to be filed within a prescribed time in our bylaws. While the National organization recognizes the position of Assistant Department Secretary the Department Bylaws for an unknown reason does not. This amendment ensures that an Assistant Department Secretary is appointed and that that individual's primary function is to prepare those proceedings under the guidance of the Department Secretary. In this manner it will relieve the Department Secretary of some of his workload while at the same time ensuring that the proceedings which are a valuable record of the Encampment will be timely submitted.

# THE DEPARTMENT OF NEW YORK SUVCW RECRUITMENT AND PUBLIC RELATIONS COMMITTEE

IT IS PROPOSED that the 136th Encampment of the Department of New York hereby create a special committee to be known as the Department of New York Recruitment and Public Relations Committee. Said committee shall provide an annual report of its activities to the Department Encampment and shall serve from its creation at the 136th Encampment of the Department of New York until the 141st Encampment of the Department of New York where it will cease to exist upon the presentation of its annual report.

Said Committee shall consist of five members of the Department of New York in good standing and consist of the Senior Vice Commander, Junior Vice Commander and three appointed members to be appointed by the Department Commander. The three appointed members shall serve for the duration of the committee's existence and one of the three appointed members shall serve as chairman and shall be elected biannually by the committee. Vacancies in the Committee shall be filled by the Department Commander as needed. Additional non-voting members of the committee may serve at the discretion of the Department Commander. The Committee shall meet at least twice annually.

The purpose of the committee shall be to study and develop policies, programs and methods designed to promote the recruitment and retention of members and associate members throughout the Department and its camps and to execute those policies, programs and methods and to encourage camps to do likewise; to study and make recommendations concerning programs, policies and methods designed to recruit members under the age of 40 throughout the Department and its camps and to execute those policies, programs and methods and to encourage camps to do likewise; to set up policies to aid the Senior Vice Commander in the execution of his duties as public relations officer to execute those policies and insure the continuity of such public relations program in the Department and to aid the Senior Vice Commander in the execution of that program. Said duties shall include creation and maintenance of a Recruitment webpage(s) on the Department website, development of other social media strategies to promote the SUVCW and recruit new members, and insure the dissemination through the media of important Civil War events and observances related to the contributions of New Yorkers during the Civil War, as well as Department and Camp events and programs.

**PURPOSE:** The purpose is to set up a Committee to bolster the recruitment and retention of new members and new younger members in the Department and its camps and too promote the organization throughout the state. It provides the makeup of the Committee, its selection, duration, gives some guidelines and mandates for its operation and provides for continuity

RE: Proposals To Be Considered At The Department of New York 2019 Encampment

- 1. Proposed Changes to the Department of New York Bylaws Recommended by the Mid Year Meeting at Ithaca, November 3, 2018 to:
  - a. Clarify wording about the graves registration awards to make it clear that there are two awards, one for a camp and one for an individual.
  - b. Clarify how Department Commanders and Past Department Commanders who pass in the year preceding an Encampment will be memorialized in the Encampment Journal.
  - c. Ensure that all camps have at least 2 signatories on each account and safe deposit box.
- Proposed Changes to the Department Bylaws Recommended by me to:
  - a. Expand the requirement of 2 signatories on each bank account (see 1. c., above) to include the Department in addition to the camps.
  - b. Establish annual Camp and Individual Awards for the placement of headstones.
  - c. Require that the names of the individual and the camp recipients of all Department Awards for the last ten years be posted on the website.
  - d. Specify that all awards are for activities for the previous calendar year.

Regarding 1 and 2, above, the Bylaws of the Department of New York, in Article XVI, require 60 days notice to the Commander and Secretary for changes to the Bylaws to be voted on at the Department Encampment. This, being sent on March 14, complies with this requirement. At the Encampment a two-thirds vote is required.

- 3. Changes I propose to the National Regulations to be referred to the C & R Committee:
  - a. Eliminate or modify the Surety Bonds requirement and make administration a National function. See Attachment 3A and Appendix A (Regulations Chapter 5, Article III -Bonds)
  - b. Corrections to Chapter 1 (Camps), Article 5 (Officers). See Attachment 3B and Appendix
  - c. Change the wording in Chapter II (Departments), Article 1(Formation) to clarify whether or not the annual report and the consolidated annual report are the same document or different and what the difference is between suspending a department and suspending a department's charter. See Attachment 3C (Existing Regulations).

Regarding 3, above, the pertinent National Regulations in Chapter 6, Article 1 say: "Section 2. (a). All proposed amendments to these Regulations must be submitted in writing or electronically to: -The Commander-in-Chief, - The Chairman of the Committee on Constitution and Regulations and -The National Counselor and received by the aforementioned National Officers and Committee Chairman no later than thirty (30) days prior to the National Encampment at which they are to be considered." Contact information for these three officers is here as APPENDIX C.

Again, a two-thirds vote is required. Since the National Encampment is August 8-11, any proposal approved by the Department of New York Encampment should be mailed no later than August 1 to ensure compliance. Note that the regulations do not say who can suggest changes, members, camps or departments so presumably any of these can do so.

- 4. Changes I propose to SUVCW Forms and Reporting Dates to expedite the flow of information throughout our Order and to reduce the work of camp and department secretaries by eliminating duplication. See attachment 4.
- 5. Resolution to oppose any requirement that all Camps have an Assistant Treasurer and/or an Assistant Secretary and instead that all accounts and safe deposit boxes have at least two signatories and, if the Secretary is absent, a substitute secretary be elected for the particular meeting before proceeding. Establish the requirement that the second account signatory check the account(s) once a month online. The Assistant Treasurer and Assistant Secretary proposal was entered at the Last National Encampment and referred for study. It could come back as is or modified for a vote at the next National Encampment. I suggest that the Department of New York Encampment approve the letter in attachment 5 to be sent by the Department Commander to the Commander—in—Chief.

Attachments 1, 2, 3a, 3b, 3c, 4 & 5 correspond to the similarly numbered sections above and provide the details of each proposal. Appendices A and B provide the existing National Regulations for reference.

# PROPOSED CHANGES TO THE DEPARTMENT OF NEW YORK BYLAWS RECOMMENDED BY THE MID YEAR MEETING PAGE 1 OF 2

The attendees at the Department of New York's Midyear Meeting held in Ithaca on November 3, 2018 voted to recommend to the 2019 Encampment that the following changes be made to the Department's Bylaws. If accepted, the Bylaws would include the wording in italics below. Existing wording is underlined.

1. Reword Article XII, Awards, Section 1. G (Graves Registration) to make it clear that there are separate awards for the individual and the Camp who/which register/s the most graves during a year. The current wording is ambiguous because it uses "Camp and/or Individuals (plural, suggesting many) preceded by "The" suggesting that there might be only one. Current wording:

The Graves Registration Recognition Award is to be presented to the Camp and/or Individuals that register the most graves with the National Graves Registration officer. Camps or individuals will report their graves registration activities to the Department Graves Registration Officer.

#### The suggested new wording:

"Graves Registration Recognition Awards in the form of a framed certificate will be presented at the Encampment to both the individual and the Camp who/which registered the most graves in the prior calendar year. Camp Graves Registration Officers will report no later than March 1 of the following year to the Department Graves Registration Officer or, if that office is vacant, the Department Commander, the number of graves registered in the prior year by individual with a total for the Camp. Graves can be located anywhere. They do not have to be located in the Camp's usual area of operation. Reports may include additional information that may be of interest such as projects undertaken, names and organizations of nonmembers who assisted, notable graves, cemetery names, etc. Camps not reporting will not be eligible nor will their members be. If there is no Camp Graves Registration Officer the Camp Secretary or Commander can provide the report."

Note: Dennis Duffy suggests that this be expanded to add awards for placement of headstones (monuments). See Attachment 2, item 2.

#### **ATTACHMENT 1**

# PROPOSED CHANGES TO THE DEPARTMENT OF NEW YORK BYLAWS RECOMMENDED BY THE MID YEAR MEETING PAGE 2 OF 2

2. Reword Section 4, Article XI, Reports. The entire section now states:

"At least one-half of the Department Journal/Encampment Proceedings shall be dedicated to the memory of any Past Department Commander who dies during the previous year. Upon the passing of a New York Past Department Commander, a full-page memorial will be placed in the Journal or Year book distributed at the next Department Encampment."

In one place this equates the Proceedings which follow the Encampment with the Journal which is printed before the Encampment and, in another place, equates the Journal with a Yearbook, which, if it is the Journal does not need not an additional name, however as is not a journal (record), Yearbook is more appropriate.

Note that generically a journal is, like minutes and proceedings, a record of what occurs made as or shortly after it occurs. Also, how does one dedicate <u>half</u> of a document and are we assuming that if a Commander dies in office he immediately becomes a Past Department Commander?

Suggested new wording for Section 4:

"Upon the passing of the Department's Commander or a Past Department Commander, the Yearbook of the next Department Encampment shall be dedicated to his memory and a full-page memorial will be placed in it."

3. <u>Second Signatories To Be Required on all Accounts/Safe Deposit Boxes.</u> Add a new article titled "Camps" which, in its entirety, shall state:

"Every Camp shall ensure that at least two signatories, one of which must be the Camp's Treasurer, are at all times authorized to write checks and or make withdrawals from any account in which the Camp's funds are deposited or otherwise kept. If online access to view or to process transactions is a feature of the account, again, two officers, one of whom must be the Treasurer must have such access (current user name and password). Two signatures are not required for a check or other transaction unless the Camp elects so. Safe deposit boxes, if any, maintained by a Camp must provide for access by at least two officers one of which must be the Secretary."

NOTE: Dennis Duffy suggests that the two signatory requirement be expanded to include the Department. See Attachment 2, Item 1.

# ATTACHMENT 2 PROPOSED CHANGES TO THE DEPARTMENT OF NEW YORK BYLAWS RECOMMENDED BY DENNIS DUFFY PAGE 1 OF 1

1. Although not discussed at the midyear meeting, it is logical that a requirement that camps have a second signatory on all accounts be extended to the Department concerning its own accounts. This can be accomplished by expanding the rewording regarding camps to say: <a href="Add">Add</a> to the Department Bylaws a new article titled "Accounts/Safe Deposit Boxes" which, in its entirety, shall state:

"The Department and every Camp shall ensure that at least two signatories, one of which must be the Treasurer of the particular entity, are at all times authorized to write checks and/or make withdrawals from any account in which the entity's funds are deposited or otherwise kept. If online access to view or to process transactions is a feature of the account, again, two officers, one of whom must be the Treasurer must have such access (current user name and password). Two signatures are not required for a check or other transaction unless the Camp elects so. Safe deposit boxes, if any, maintained by the Department or any Camp must provide for access by at least two officers one of which must be the Secretary. The second signatory will check the account online monthly to see if all looks OK."

2. Headstone/Monument Placement Recognition. The Mid Year Meeting wrote a recommendation to clarify the wording in the bylaws regarding the Department's Graves Registration Awards. I suggest this be extended to add awards for placing monuments (headstones). The expanded recommendation is in italics below.

"Graves Registration and Headstone Placement Recognition Awards in the form of a framed certificate will be presented at the Encampment to the individual and to the Camp who/which registered the most graves in the prior calendar year and to the individual and to the Camp who/which placed the most headstones. Hence there are four awards. Placement, as used here, means original and replacement headstones. Camp Graves Registration Officers will report no later than March 1 of the following year to the Department Graves Registration Officer or, if that office is vacant, the Department Commander, the number of graves registered and the number of headstones placed in the prior year by individual with a total for the Camp. Graves can be located anywhere. They do not have to be located in the Camp's usual area of operation. Reports may include additional information that may be of interest such as projects undertaken, names and organizations of nonmembers who assisted, notable graves, cemetery names, etc. Camps not reporting will not be eligible nor will their members be. If there is no Camp Graves Registration Officer the Camp Secretary or Commander can provide the report."

- 3. I suggest that the Bylaws be changed to require that all recipients, individual and camp, of all the Department's awards for the last ten years be placed on the web site.
- 4. Calendar year activities. Some of the current awards contain wording which says "during the year" Another says "a net increase" without specifying any time period. Sometimes the website shows a calendar year and sometimes dates such as 2015-2016 OR 2016-2017. I suggest that the Bylaws be amended to include a general statement that all awards are for activities conducted during a calendar year.

# ATTACHMENT 3A CHANGES PROPOSED TO THE NATIONAL REGULATIONS BY DENNIS DUFFY

1. Chapter V – General Regulations contains a requirement that certain officers, including camp treasurers, be bonded either commercially or personally. The details are in ATTACHMENT III-A.

The minimum amount of coverage available in the market is \$10,000 and the premium is about \$130.00 annually. This is one quarter of the Moses A. Baldwin Camp #544 budget, including contributions, and it is 35% of the camp portion of its dues (\$374 from 34 members). The Baldwin camp has a reserve of just under \$1,000 so the maximum exposure of \$2,500 is reached in January when the annual dues (\$1,500) have been received and deposited but the Department and National shares have not yet been transmitted and the check cleared. In the event that the treasurer were to steal some or all of the camp funds the surety company would not pay until a conviction was obtained.

This regulation does provide that personal surety (another person agreeing to make good if another steals) can be substituted for a bond purchased in the market if the Camp Commander approves. If this method is to be relied upon, National should provide an acceptable form and instructions (witness(es)/notarization required?, copy filed with the Department/National?, etc.) Also, this "personal surety" means that if a treasurer steals say \$2,000 and another member has provided that personal surety that other member is on the hook for the entire \$2,000. Wouldn't it make sense for ten members or all of them to share in this liability? Isn't this exactly what happens when there is no bond? This being the case how could anyone in or out of the Order be induced to provide personal surety?

Bond premiums do not seem to be the best use of funds especially for small camps with limited assets. We ask that National review this regulation to see if:

- a. Camps can be excluded from it entirely, or, if not,
- b. The regulation apply only to camps (and perhaps departments) which have an exposure at any time during the year of at least \$10,000.

If it is necessary to keep the bonding requirement it would seem more efficient for National to make arrangements (establish a program) with an insurer to which camps and departments could subscribe rather than have camps and departments individually enter a market in which few, if any, have any knowledge.

Section 5 of this regulation talks about the bonds "running to" a particular officer or council. We understand that this refers to who gets paid by the insurer. Shouldn't the payee be the Camp or Department which suffered the loss, or do we misunderstand the meaning of "run to?"

Resolution that the Department Commander write to National asking that the above questions be explored.

# ATTACHMENT 3B CHANGES PROPOSED TO THE NATIONAL REGULATIONS BY DENNIS DUFFY PAGE 1 OF 2

Article V - Officers. Should be retitled OFFICERS & DELEGATES as delegates are discussed here.

#### Section 1.

- A. The "and" between Memorials Officer <u>and Patriotic Instructor should be replaced by a comma as these are two separate positions.</u>
- B. The sentence, "The Commander, Secretary, and Treasurer shall not serve on the Camp Council." should be moved to Article X, Camp Council.
- C. Counselor & Graves Registration Officer are missing and should be added.

Sections 1 & 2 would be less wordy and easier to understand if they were written as follows:

- Sec. 1. Elections shall be held at a regular meeting of the Camp between the first meeting in October and the first meeting in December, inclusive.
  - a. The elected officers are Commander, Senior Vice Commander, Junior Vice Commander, Secretary, Treasurer, or Secretary-Treasurer, and the three members of the Camp Council. These shall be elected by a majority.
  - b. Member of the Camp Council, Delegates, and Alternates shall be elected by a plurality.
- Sec. 2. On assuming office, the Commander shall appoint the Patriotic Instructor, Chaplain, Counselor (added), Historian, Graves Registration Officer (added), Memorials Officer, Guide, Color Bearer and Guard.

Section 4. Rank of Officers. Last in this list is "Welfare Committee," the duties of which are described in Section 1 of Article IX. In the ranking, "Welfare Committee" should be restated as "Members of the Welfare Committee" or Chairman of the Welfare Committee" (similar to what is done for the Camp Council) as the committee is not an officer in itself but, apparently, its members are.

Article VII. Elected Officers Job Descriptions & Duties.

- Job descriptions should be written for Delegate(s) and Alternate(s) and included here.
- 2. Section 5. Treasurer. Item (g) makes the Treasurer responsible for preparing a report on the financial condition of the Camp for review and approval by the Camp Council but does not state the frequency. The Camp Council is charged with reviewing and "passing upon" a quarterly report. Can someone provide us with a sample of such a quarterly report? Shouldn't these two be consistent with "quarterly" added to the Treasurer's description and "passing upon" replaced with "approval" for the Council? Better still, why do we need a quarterly report? What is supposed to be in this that is not in the monthly report? If there are differences (monthly vs quarterly) shouldn't they be spelled out?

Article IX. Optional Officers Job descriptions & Duties. Section 1. Welfare Committee

# ATTACHMENT 3B CHANGES PROPOSED TO THE NATIONAL REGULATIONS BY DENNIS DUFFY PAGE 2 OF 2

As above, a committee is not an officer and all of Section 1, Article IX should be moved to Article XII – Committees.

#### Article X. Camp Council.

- 1. In listing the activities of the Council "e" and "g" are both used twice.
- 2. Item (f) says that one of the Council's activities is "Reviewing and passing upon a quarterly financial report of the Camp." Why is a quarterly report needed? What is in it that isn't in the monthly report?
- 3. The first item 'g' says the Council will "render" a complete report.
  - a. Does this mean that Council itself compiles the report? Does the Treasurer have no role?
  - b. Shouldn't calendar year be fiscal year?
  - c. Can someone provide us with a sample of such a report?
- 4. Item c says that the Council must "examine and pass upon all accounts and bills incurred by any officer and committee or the Camp. Is this done prior to payment? How does this mesh with the Secretary's description which says "he shall draw all requisitions upon the Treasurer from the expenditure of money, upon order of the camp, and <u>submit the same to the Commander for his approval</u>. Keeping a book for that purpose." Who approves a bill before payment? Is it the Council or the Commander or both? If the item is in an approved budget, why would any additional approval be needed?

It seems to me that we should have a budget approved by the members, the Treasurer authorized to make payments if the item is in the budget and someone verifies that the work has been done or the goods received, the Treasurer required to do the reporting and Council should annually audit (rather than "review") all the transactions, receipts and expenditures, and the bank balances.

# ATTACHMENT 3C PROPOSED CHANGES TO THE NATIONAL REGULATIONS BY DENNIS DUFFY

Annual report vs Consolidated Annual Report; Suspend Charter vs Suspend Department; Threshold one year or five?

National Regulations Chapter II (Departments) Article 1 (Formation) state:

Section 10. When a Department fails to file their <u>annual report</u> and pay the annual per capita dues by the date specified in the Regulations for five consecutive years, the charter of the Department shall automatically be suspended; the Department shall lose all voting rights at the succeeding National Encampment, including all Department PDC's and Past Department Commander and Department Commander; the Department may not be reinstated until the succeeding National Encampment has occurred.

Section 11. Any Department which fails to file the <u>annual consolidated report</u> by the date specified therein shall be automatically suspended. The Commander-in-Chief shall issue a General Order noting the automatic suspension.

Section 12. Any Department which fails to file the annual EIN report by the date specified therein shall be automatically suspended. The Commander-in-Chief shall issue a General Order noting the automatic suspension.

The underlining is mine.

- 1. I understand that the <u>annual report</u> is form 35. Can you tell me what the <u>annual consolidated report</u> is? If both of these refer to the same form 35 shouldn't "consolidated" be removed so as to avoid the suggestion that there are two different reports?
- 2. Is there a difference between suspending a Department and suspending the Department's Charter? Is this described somewhere in the Regulations?
- 3. Is section 10 necessary as section 11 suspends after one year of non-compliance?

# ATTACHMENT 4 CHANGES PROPOSED TO FORMS AND REPORTING DATES BY DENNIS DUFFY PAGE 1 OF 2

#### **OBJECTIVES:**

-Expedite the flow of information, -Eliminate duplication to reduce the work required of camp & department secretaries, and -Eliminate confusion.

BACKGROUND: The SUVCW periodically reviews its forms to see if changes are necessary or beneficial. For example the Camp Status Report (form 30) and the Camp Annual Report (Form 27) are scheduled for review in December, 2019 while the membership application (form 3) is scheduled for review in March, 2020, so it is timely to suggest that the Department of New York ask the Council of Administration to make the following changes:

- 1. Relocate reporting of the audit completion date from the Installation Report (form 22) to the Annual Report (form 27). Why delay the installation report because the audit has not yet been done? This is usually be the case if the audit is done in January or February after the close on December 31 of the fiscal year for most camps. Installation reports should be in the mail a day or two after the Installation which, in many cases, is in December, sometimes earlier or later but still before the audit can reasonably be done. The sooner the installation report is received by Departments the sooner they can update their contact information on websites and elsewhere.
- 2. Remove from the Installation Reports of camps (form 22) and departments (form 49), the requirement to restate, year after year, who the past commanders were. This is not information which is going to change!
- 3. Eliminate the requirement that a camp roster be attached to the Installation report. For most camps an updated roster will follow in a couple of months attached to the Camp Annual Report after renewals have been processed so it will be more accurate. What is the benefit of the existing duplication?
- 4. Change the annual reports for both camps (form 27) and departments (form 35) to specify that the report is for the calendar year (January 1 to December 31) immediately preceding the filing of the report and that the balance on hand should be reported as of December 31. If it is not clear that all camps are reporting for the same period, how can departments add them up?
- The Veteran status question should be added to the application alongside the Eagle Scout Certificate and ROTC Award questions as there is no other vehicle for obtaining this information.
- 6. Eliminate the form 30 for new members. Once 5, above is done, there will be no difference at all between the information on the application and the form 30 so the form 30 can be eliminated saving a lot of transcription and photo copying thus reducing work and the possibility of error and saving paper. If this is adopted form 3 should be changed to add instructions to send 2 copies with payment to the Department Secretary.
- 7. Change the name of the form 30 from Camp Status Report to Member Transaction Report as the latter is a more accurate description of the form's function.

# ATTACHMENT 4 CHANGES PROPOSED TO FORMS AND REPORTING DATES BY DENNIS DUFFY PAGE 2 of 2

- 9. Change the practice of being able to "catch up" reporting by adding member transactions on camp annual reports. Every transaction, should be supported by a form 30 except new members for which the 30 is a duplication of the application (see #5, above). This will make the Camp Status Report, just that, a status report (no transactions) and a lot simpler.
- 10. National Regulations Chapter 1(CAMPS), Article 1, section 16 states that "Any <u>camp</u> which fails to file the Form 22, Form 27, or <u>EIN report</u> by the dates specified herein shall have its charter automatically suspended. The Department Commander shall issue a Department Order noting the automatic suspension." Note there is no such thing as an EIN Report for Camps. Camps report their EINs on the Camp Annual report, form 27. Departments extract this information from the Camp Annual reports and complete the EIN report. Changes in EIN are extremely rare so to keep copying the same information over and over just makes work and introduces the chance of error. Since departments send to National a copy of each camp's annual report containing its EIN, there is no need for an EIN Report from the department. The EIN report should be eliminated, the camp annual report which already asks for the EIN should be modified to ask "Is this EIN the same as last reported \_\_\_\_\_YES \_\_\_\_NO and the Regulations should be reworded to say: "Each camp and department must have an IRS issued Employer Identification Number (EIN) and report same on its application for a charter and subsequently on each annual report. Absence of this information means the report is incomplete and will trigger immediate suspension."
- 11. The deadline for a camps to send in their form 27 should be moved up to February 15 and for Departments to send in their Form 35 to March 31. This will increase the time Departments have to summarize the camp reports from 4 to 6 weeks and greatly expedite the flow of information. The current schedule means that some departments don't have the prior year's information until after their Encampments. The Autumn, 2018 Banner reported that at the last National Encampment the CIC referred to the C & R Committee for study a recommendation from the Executive Director that strong disciplinary action be taken against Department commanders and secretaries who neglect or refuse to file form 35 (Department Annual report) on time (May 31). This ignores the underlying problem which is camps not reporting on time or reporting incomplete or inconsistent information which the Department Secretary has to try to resolve. Some camps don't mail the reports until early May giving Department secretaries a scant 3 weeks to do their work. There is no reason why camps should need until April 30 to report on the prior calendar year.

Dear Commander-in-Chief Shaw:

At the last National Encampment a proposal was entered to require that all departments and camps have Assistant Secretaries and Assistant Treasurers, a resolution with the good intention of positioning camps to continue business as usual in the event of the death, disability, or resignation of the Secretary or the Treasurer. This was referred for study.

The Department of New York has considered this proposal and has the following comments:

- This proposal cannot become a <u>requirement</u> because many camps would not be able to comply and would have to be suspended. A <u>recommendation</u> to the same effect is fine.
- 2. Better requirements, which all would be able to meet, would be:
  - a. That every department and camp always have <u>at least</u> two (2) signatories on all accounts and safe deposit boxes and that the second signatory periodically check the accounts online to verify that all seems OK.
  - b. That, in the absence of the Secretary, departments and camps elect a Secretary for the meeting before proceeding.

We would appreciate it if these comments be considered before a final decision is made on this proposal.

# Sons of Union Veterans of the Civil War (SUVCW) REGULATIONS CHAPTER V - GENERAL REGULATIONS Article III Bonds

<u>Section 1</u>. The bonded officers shall be as follows: The Camp Treasurer (and the Camp Secretary and Camp Council when holding funds of the Camp); Department Secretary, Department Treasurer (Department Secretary-Treasurer); National Secretary, National Treasurer (National Secretary-Treasurer), National MAL Coordinator, National Quartermaster, Jr. Vice Commander-in-Chief, Assistant National Treasurer(s), National Executive Director and National Patriotic Instructor. Also Department Commanders if so ordered by Department By-laws.

<u>Section 2.</u> The above officers shall be bonded in amounts to be fixed by the various Council of the respective bodies, in some acceptable surety company, provided that Camp and Department Officers may furnish acceptable personal surety. Bonded officers shall be held liable for the funds remaining in their possessions until payment to their successors who have been properly installed, qualified and have given bond and have receipted for all money and property.

<u>Section 3.</u> When a Department Commander, who is required to be bonded, through his own fault fails or neglects to furnish sufficient bond within thirty days after assuming office, the Commander-in-Chief should remove him from office pending action by the Council of Administration.

<u>Section 4.</u> The Bonds of the Camp Treasurer and Camp Council shall be approved by the Camp Commander; the bonds of the Department Secretary and Department Treasurer (Department Secretary - Treasurer) shall be approved and held by the Department Commander; the bond The National Secretary and National Treasurer (National Secretary-Treasurer) shall be approved and held by the Commander-in-Chief.

<u>Section 5.</u> The bonds of the Camp officers shall run to the Camp Council. The bond of the Department Commander, if one is required, shall run to the Department Council. Bonds of all other officers shall run to the officer by whom they are held.

<u>Personal Surety.</u> A guarantee provided by an individual (rather than an insurer) for the acts of another person. DEFINITION FROM BLACKSTONES LAW DICTIONARY.

Surety Bond, in this application also known as a fidelity bond is a three party agreement. If the <u>Principal (1)</u> does not fulfill the obligation the <u>Suretor (2)</u> pays the O<u>blique (3)</u>. Thus, bonds are said to "run to' the obligue, the person who gets paid if the obligation is not met.

#### APPENDIX B

National Regulations Chapter 1 - Camps

Article V Officers

Section 1. The officers of a Camp shall be: Commander, Senior Vice Commander, Junior Vice Commander, three Members of the Camp Council, Chaplain, Color Bearer, Guard, Guide, Historian, Memorials Officer and Patriotic Instructor, Secretary, Treasurer (or Secretary-Treasurer). The Commander, Secretary and Treasurer shall not serve on the Camp Council.

Section 2. The Camp Commander, Senior and Junior Vice Camp Commander, Camp Council, Secretary, Treasurer (or Secretary-Treasurer), Delegates and Alternates shall be elected at a regular meeting of the Camp between the first meeting in October and the first meeting in December, inclusive. A majority vote shall be required to elect all elective officers, except members of Camp Council, Delegates and Alternates, who shall be elected by a plurality vote. On assuming office, the Commander shall appoint all other Camp officers.

Section 3. The officers of Camps shall be installed at a regular meeting of the Camp to be held between the first meeting in September, and the first meeting in the following January, inclusive, by a person designated by the Department Commander who shall make report thereof upon the prescribed blanks furnished to him. Said dates of election, and installation to be fixed by each Department and become part of the Department By-Laws. The Council of Administrationshall have authority to grant exceptions to the dates prescribed by these Regulations for Camp elections and installations of Officers, when requested, for adequate reasons, by a Department.

Section 4. Any vacancy which may occur in an elective office of a Camp shall be filled temporarily by the officer next in rank. Such vacancy shall be filled for the unexpired term by the Camp Council.

In accordance with the Constitution and Regulations of the Sons of Union Veterans of the Civil War, Chapter I, Article I, Section 20, I respectfully request that the COL David Ireland Camp #137 be reinstated to the Department of New York as an unincorporated association until which time we regain our tax-exempt status when we will request full reinstatement.

Following an investigation by our current Camp Treasurer, Thomas (Toby) Crounse, we have learned the following concerning the revocation by the IRS of our tax-exempt status:

- The Camp's tax-exempt status was revoked for failure of the Camp Leadership at the time to file form 990N for years 2009, 2010, and 2011.
- The IRS revoked the Camp Tax Exempt Status on 15 May 2011.
- The Revocation was posted by IRS on 11 September 2012.

Camp#137 has less than \$1000 in assets and an annual income of less than \$5000. We understand that while operating as an unincorporated association we must take no action that could jeopardize the tax-exempt status of the Department of New York and/or the National Organization.

Please note the suspension of our tax-exempt status occurred prior to current Secretary John Goodnough and I joining the SUVCW and current Treasurer Toby Crounse was at the time an ordinary member of the Camp and not a member of the Camp Leadership. Nevertheless, we regret this transgression and will do everything within our power to rectify it.

Thank you for your cooperation in this matter.

"Rally Round the Flags" Committee Report

Commander McGuire and Brothers of the Department of New York,

The end of the "Rally Round the Flags" report last year announced that the data base with the 472 flags still needing preservation was complete. The data base breaks down, as to where the regiment that carried a particular flag still needing preservation was raised by county and mustered into United States service. The 500 Civil War Flags that were previous preserved by the state have also been added to the database. The committee intends to use this information to personalize correspondence when seeking support and funding, from State Senators, Assemblymen, County Legislatures, City and Town Officials, allowing us to send them information pertaining to the Flags and the Regiments recruited in their district, county, city, town or hamlet.

The committee decided to focus attention and concentrate on one county (Albany) as a trial county; a letter was written (See Attached) asking for support in seeking funding at the State level to continue conserving the flag collection. Each letter was personalized listing the Regimental and National Flags yet to be preserved that were carried by men from Albany County.

One hundred and twenty eight letters were mailed, one to every official in the County of Albany. As to date, we have received zero response to our request for help in saving the Civil War Flag Collection. I have no answer for the unpatriotic, negative response from the 128 Albany County Officials. Needless to say, it has been the same outcome since the start, dealing with the state legislature, and the results from the sample of Albany County is not encouraging in our endeavor to gather support. According to our list, 45 Regimental and National Flags associated with Albany County still need conserving. Each letter that was mailed listed the flags still needing preservation that were carried by regiment raised and mustered into US Service from Albany County.

Another New York State budget year has gone by another year of watching the annual state budget expand to a record 175 billion and again no money for the flag collection, the 5 million needed to preserve all the Civil War flags, seems like a very small amount when compared to the total budget. When you read in the paper the state will spend 26 million just to allow people to vote 9 days before Election Day you have to wonder where these flags stand, in the minds of our elected officials.

On top of all the above, the Committee received notice of the dismantling of the New York State Battle Flag Preservation Project, a cooperative effort between the NYS Department of Military and Naval Affairs who administer the NYS Military Museum and the NYS Department of Parks, Recreation and Historic Preservation. The States "Commitment to Conservation" the collection and the ability to make donations through "The Natural Heritage Trust DMNA Flag Project" is no more. The state government's commitment to conserve the New York State Battle Flag Collection has fallen well short, with still close to 75% remaining to be conserved and stored, and of that 472 New York Regimental Civil War Flags.

Where does the Rally Round the Flags Committee go from here, five years of trying to raise awareness to the fact that a once worthwhile endeavor was slowly being disassembled, by the very people who were given the task to save it? The money that was appropriated to preserve the flags yearly by the State Legislature stopped with the present administration. The "exciting new chapter in the New

York State Battle Flag Collection's history", that started in the year 2000 has come to a distressing halt.

The committee will be asking at the encampment that the Department Rally Round the Flags Resolution and the "Rally Round the Flags" Committee be extended for another five years, we will not give up in our obligation as Sons of Union Veterans to save and preserve these glorious banners that our forefathers fought and died under.

Please find herein the Annual Report of the Colonel Augustus Van Horne Ellis Camp 124 SUVCW for the May 2018 to April 2019 period.

May 2018 – The Camp held Memorial Day Services at the grave of William Henry Carpenter, Co. K, 39 NYSV, killed in action Fair Oaks, Virginia on January 24, 1865. In addition, Brother Albanese speaking for the Scholarship committee announced the winners of the 13<sup>th</sup> annual scholarship competition. First place went to Harrison Garcia of Clarkstown North High School. Second place went to Kevin Koudelka of North Rockland High School and third place went to Mathew Marino.

July 2018 – The Ellis Camp hosted the bi-annual Shohola Railroad Disaster Memorial Observance on July 15<sup>th</sup>. In addition to the Ellis Camp, remarks were presented by the Pike County and Shohola Historian, George J. Fluhr. Another featured speaker was Mr. Patrick McCullough, PCC Archibald Gracie Camp #985, SCVCW.

September 2018 -- Camps Brothers manned a SUVCW information table at the 43st Annual Civil

War Days at Museum Village, Monroe, New York in Orange County. Also, present at the Civil War Days was Catherine M. Walter, Curator of the Robert R. Livingston Masonic Library of Grand Lodge in New York City. She was displaying a wooden badge carved by Sgt. William C. Lilly, Co. D, 149 NYSV. She invited SUVCW members to utilize the Masonic library in researching veterans of the Civil War who were Masons.

October 2018 – Brother William Stump announced that he created a new Facebook Page with daily Civil War related posts for the camp. That page can be found at Facebook.com "SUVCW Camp # 124 Col. Augustus van Horne Ellis" or with a shortcut of @SUVCW 124.

November 2018 - Brother Paul Ellis-Graham proposed this question for the 14<sup>th</sup> annual scholarship essay competition to be announced on Memorial Day 2019: "In 1869, one hundred and fifty years ago, the 15<sup>th</sup> Amendment gave Americans the right to vote. By 1896, those rights were significantly diminished. How did that happen? Who or what was responsible? And finally, how is the issue of minority voting rights still an issue today?"

**December 2018-** The camp held it annual Christmas party and held elections for it 2019 elected offices.

**January 2019** - Installation officer Jeffrey Albanese, PDC installed the following Ellis Camp officers for the next year: Camp Commander Jeffrey Albanese, SVC John Dickerson, JVC William Stump, Sec. Bruce Crandall, Treas. Raymond

Brown and Council member (term expiring 2022) James Meaney. Appointments were made for the following positions: Patriotic Instructor & Signals Officer, William Stump; Chaplain, Barry G. O'Neill; Graves Registration Officer, Civil War Memorials Officer & Camp Musician, Bruce Crandall; Historian & Eagle Scout Coordinator, James Meaney.

**February 2019** - Brother Bruce Crandall is working on a virtual cemetery on FindaGrave which will list the known gravesites of members of the 114th NYSV, his greatgrandfather's unit. To date he has located the final resting places of 764 of the unit's 1129 members.

March 2019- It was announced that Raymond Brown, PCC of the Ellis Camp had won the Department's Oliver P. Clark Plaque for 2018 and that the Ellis Camp had won the John G. Kiernan Cup for the same year. The camp had a presentation from two dedicated metal detector hobbyists about their hobby including a display of some of their finds including Civil War related items.

April 2019- The Camp filed its annual report on time with the Department. The report indicated that the Camp lost 3 members only one of which was lost for failure to pay dues. In addition, the camp gained and initiated 5 new members three of which were under the age of 40. Dear Commander, McGuire and Brothers of the Department of New York:

Please let this letter serve as the Annual Report of the Treasurer of the Department of New York, SUVCW to the 136th Encampment of Department of New York.

I have provided two handouts to the Encampment. The first provides the Encampment with the current balances in each account along with the current balances in the accounts just prior to last year's Encampment. The checking account shows a significant increase which reflects the fact that last year's Encampment was unusually early and prior to the deadline for filing annual reports in addition the Encampment was primarily the responsibility of the DUVCW and we did not need to collect monies for the banquet, nor did I receive sufficient advance monies from the raffle to make a deposit. This year's checking account contains almost all Camp per capita funds, advanced banquet payments, a substantial sum from the raffle and registration fees. Careful note should also be made of the footnotes that accompany the account balance sheets.

We also have an account presently held by the Department Archivist, in violation of the national regulations and which has not been audited by the Department council. That account was supposed to be turned over to me after I believe the 134<sup>th</sup> Encampment. The Archivist claims he sent me paperwork on that account which I believe was simply to put me on as another signatory. That was not the agreement nor is that in conformity with the Regulations. I am requesting that he be directed to turn over all the funds in that account directly to me or my successor forthwith so that it can be deposited into the account as stated in the Archives policy adopted by this Department.

That handout also provides the proposed Budget for the upcoming fiscal year, which we will vote on later today; along with the approved budget of last year. As always, note that the fiscal year for the Department runs from July 1 through June 30. Please further note that we are currently still within the 2018/2019 fiscal year. Please further realize that almost all the financial activity of the Department occurs between April and June of each year. The primary source of all the Department's Income comes from three places. These are our Department dues (\$6 per member), our raffle, and a small amount from our Encampment registration fee. Most of our monies however continue to come from the dues which accounted for 90 % of our income, of which about 75% of those dues are a pass through to the National Organization. The less members we have the less we collect the less income we have.

Most of our budget numbers reflect pass through income and a number of budget items that are mandated by our bylaws. The budget reflects a small negative balance which on its face may seem good however to get there I had to cut out several hundred dollars from our discretionary portion of our budget from last year.

Why the decrease in the budget? Because this Department is facing a crisis. As I said earlier less members means less dues collected means less income. Last year I noted in my report a decrease in membership. It is now, in my opinion, reaching crisis proportions. In 2013, my last year as Commander, and

the only year of that period that I have numbers, our per capita check to National was \$11,041. The amount of per Capita directly reflects membership. That year we had 541 members of which 459 of them were dues paying members (Juniors and Life Members do not pay per capita). In 2014 my first year as Treasurer our per capita check to National was \$10,717.00, and the next year \$10,223. However, in the last 3 years that number plummeted to around \$9,400 for the next two years and this year it will be approximately \$8,519. Our total membership now is only 428 members, our dues paying members down to 368. We have lost 113 members, which is more than 20% of the Department membership, in 6 years. This is not meant to point fingers at anyone as this is not just out problem, the most recent issue of the Banner also noted a decline in membership between 20017 and 2018 and other fraternal organizations and veterans' groups are seeing the same thing.

But with all due respect to my brothers who wish to spend time amending the CRR, or talking about awards or flags or gravestones or memorials all of which have the place and are important but we really need to drastically shift our focus from them to figuring out how to retain our members, how to recruit new members and how to recruit younger members. This should be the focus of our midyear meetings and our Encampments; it should be the focus of this very Encampment and the next and the one after that. For if we neglect this issue there will be no one to register those graves, save those monuments, mend those flags.

In that regard I have a second handout which includes a resolution to appoint a 5-year special committee on recruitment and public relations to find ways to stem the losses and to execute them I strongly urge everyone to support it. But that should not be the end of it. We need to discuss that and possible solutions today, not tomorrow or the next day. We need to make the time to have a serious discussion of what can and should be done and get this committee on its feet running.

Now as Treasurer I am obligated to remind everyone of the importance of filing your camp 990s. I mentioned that last year at length, as did the Department Commander, Secretary and Counselor as we and those who preceded us did the year before that and the year before that. Now we are faced with several camps that are suspended because at some point they ignored those reminders. I am hopeful that we can figure out a way to get those camps unsuspended and not go through this process again.

Now some advice, as I have frequently stated since I been giving reports at these Encampments as the GAR Highway Officer in 2005, all officers elected or appointed at any level need to become familiar with and abide by their job duties and responsibilities under both the National Rules and Regulations, the National Job Descriptions, National Policies, the Department Bylaws Department Policies and the Camp bylaws and see that they are followed. There is really, no excuse whatsoever for those who seek and obtain these offices for not knowing their responsibilities, that is particularly true for those of us who seek elective office. We have bylaws that impose additional duties on our officers, for instance being our public relations officer, something I pushed for a number of years ago. Despite that being a duty, I have rarely if ever seen any of the holders of that office perform that function.

In addition, and equally important is knowing what happened at the Encampment you were elected at. Encampments pass Bylaws, Resolutions and approve recommendations and expect the Commander or his designee to see that they are carried out. So, it's important to note them at the encampment and to follow through with them. That does not always happen. It is here at the Encampment that it is decided what the Department can and cannot do as long as it does not violate National Rules and Regulations. We as officers of the Department follow your dictates as you represent the very essence of this organization the members and the camps. They are the life blood for which we as a Department exist. You as those representatives have the right to expect that we follow those dictates.

Further, as mentioned earlier, it is more important than ever that we attract new members and to keep those who are already members we as a Department need to communicate with them and keep them involved. We as Department officers, both elected and appointed, who come from most of our camps

should as part of our duty keep our respective camps apprised of Department and National goings on. It is important for a Department Commander to communicate with the Camp Commanders regularly on what is going on both in the Department and on the National level and to encourage them to also communicate that to their camps. It is important that the Commander and the elected officers continually communicate with each other and that ALL participate in those discussions. It is important that appointed officers regularly communicate with the Department Commander and that they reach out to their respective counterparts at the Camp level. We also need to get our newsletter out to our members on time and we need to keep our website both active and interesting.

We also need to respect the chain of command. While it may be appropriate for an officer to communicate with his direct counterpart at the National or camp level to perform his duties it is not appropriate for a member, even an officer to communicate directly with the Commander in Chief without the permission and consent of the Department Commander. It is the Department Commander who is the liaison with the national organization, not anyone else unless he delegates such authority. If there are issues the Department Commander needs to know what they are, and he needs to know what is going on. To go over his head to me it is disrespectful. I did not like it the one time it happened when I was Department Commander, I do not like it now.

Finally, I have a proposed Bylaw change which I have also handed out and would like to briefly discuss. This Bylaw change was not posted 60 days prior to the Encampment so I will need two-thirds vote to waive that rule before we can consider it. It relates to the Department Secretary perhaps the most thankless and paperwork consuming job in the organization. No one wants to do it. It is a job you usually have a hard time finding someone to take on either Camp or Department level. It is so thankless that if you perform if for 10 years the organization awards you with PCC status or PDC status. When you get a good one you do not want to lose him. That is the case here. He needs assistance and although an Assistant Department Secretary is a recognized position, we for some reason did not include it in our bylaws and we need to do so first because it makes sense and secondly because otherwise one of us will have to take the job.

In closing, I would like to first commend Brother LeMay for a fine start for our new website. It is a great improvement and I am sure he will make it even better as we go along. I believe that social media has a part in keeping and attracting members and I believe a dynamic and interesting and informative website is a start. In addition, I ask all of us to recognize the hard work and substantial contributions our Department Secretary Bob Pugsley has made to the Department and the order for many years and continuing effort to do so. I would be remiss in not recognizing the hard work over this past year by our current Commander, Leo McGuire. Having sat in that chair I understand that it is not an easy position to hold. I would also like to thank all of you for your support over the years and I look forward to continuing to serve the Department and the Order in whatever fashion it chooses.



## Annual Report of the Department Eagle Scout Certificate Coordinator (2018-2019)

Commander McGuire, Officers, and Brothers of the Department of New York,

As an Eagle Scout, it has been an honor to serve this past year as Department Eagle Scout Certificate Coordinator for the State of New York. Upon taking the position on April 21, 2018, I first reviewed the Eagle page on the Department's website to determine which camps were covering which Boy Scout Councils and then contacted each Camp's Coordinator to confirm they were still the Eagle Coordinator and that the listed contact information was correct. If the listed Brother was no longer doing or holding the position, I then contacted the Camp and got a proper name and contact information.

There are currently 15 Boy Scout Councils covering New York State. Our website was showing 16 Councils. Two councils merged 2 years prior, so the Eagle page on the Department website was updated with a proper listing of Council names, Camp assignments to each Council with the Eagle Scout Certificate coordinators name and contact information.

A letter was sent in May, 2018 to each of the 15 Boy Scout Council Executives introducing the Sons of Union Veterans of the Civil War (SUVCW) to them and explaining our Eagle Scout Certificate Recognition Program. I asked them to use copies of the letter to notify each Troop and District in the Council of our Eagle Certificate Program. I received positive response from the Councils by listing the SUVCW Eagle Program on their websites and in their Council and District newsletters. Several Councils responded to me on thanking SUVCW for providing the Recognition Program.

On June 25, 2018 the Department Commander was provided the "2017-2018 Annual Eagle Scout Report, Department of New York, Sons of Union Veterans of the civil War" to forward to the SUVCW National Headquarters. Of the 17 camps within the Department 9 Camps responded. 119 SUVCW Eagle Scout Certificates were issued by 8 Camps and the Department covering the period June 1, 2017 to June 15,2018.

For the current period of June 16, 2018 up to a cut off of April 15, 2019, for this encampment, 12 of the 16 camps responding and the Department for the first 10 months of the current reporting period, 99 Eagle Certificates have been awarded by 9 Camps and the Department.

With the efforts being done, we are still only reaching a small number of Eagle Scouts across the state with our Recognition Program. We must continue to remind the Boy Scout Councils, their Districts and the individual units of our Eagle Scout Certificate Recognition Program.

I would like to thank all the Camp Eagle Scout Coordinators for their efforts and support of the SUVCW Department Eagle Scout Certificate Recognition Program.

### Final Report of the Memorials Officer May 2019

### General Thomas Monument

As reported to the 2018 encampment, the beech tree that has rained down large limbs and small branches, onto the Kellogg family plot that contains the General Thomas monument, was removed on Friday August 11, 2017. Mention was also made of upcoming fundraising related to saved wood. A project involving a limited edition of pens crafted from wood was conceived. The full story, with photograph, is in an attached story from the Willard Camp *Guidon* that explaines the entire process. In summary, two prototype pens were produced from tree branches collected prior to the tree removal. One pen was of a standard slim line style and the other was a Civil War-themed pen. The top of the themed pen had a replica Springfield miniball while the writing tip was made of a replica Colt minie ball. The pen's clip was a Springfield musket. Twenty total pens were produced and many were sold at the annual "Evening at the Earl" at Oak wood Cemetery. One pen was purchased by Willard Camp for the annual auction of items associated with this 2019 encampment. The two prototypes have been held in reserve for a special auction that is being discussed with Oakwood Cemetery. It is anticipated well over \$1000 will be generated from this small project.

Another attached *Guidon* article outlines Brother Tom Maggs journey with Oakwood Cemetery. Part of that journey involves the dovetailing of the priorities of Willard Camp, the Department of New York and Oakwood Cemetery. In the article the final project of the rejuvenation of General Thomas plot is explained. The re-casting of the wrought iron fence has begun. Anonymous donations have allowed some fence sections to be reproduced but that only covers about 50% of the total cost. Another \$12,000 needs to be generated and several fundraising projects are being considered. Sponsorship of fence sections thorugh monetary donations is an example.

Routine cleaning of the plot has occurred. Brothers from Willard Camp have returned to clean the monument with D/2 solution which prevents biological re-growth and helps brighten the stone.

### New York State Memorials

Work continues on the Access database of New York State Monuments that was discussed at the 2017 Encampment. Apparently over 100 monuments were submitted for the National database using the Access database. Being done in Access meant that the data were arranged as needed for Form 61. However, only the data, and not the developed application, was recovered. At this time the location (coordinates) of each of the monuments is being determined using geographic information systems (GIS) and Google Earth/Google Maps. Once exact locations are determined it is hoped that a nearby camp will volunteer to complete Form 61. Alternatives to this tedious process are being sought. One simple alternative would be to prepare a list of monuments and their locations for the Department website. Decisions on how to accumulate this information should be done in the near future:

- Should the monument information from the old Department website be reconstituted on the new Department website. If so, what form should it take? Should photographs be included?
- 2. Should the information be combined with the Access database that has been recovered and submitted piece-by-piece to the National database?

- 3. Is it worthwhile to trace the loss of the Access database and determine why New York data were never properly included in the National database?
- 4. What, if anything, can be done to simplify the monument submission process at the Department and National level? Can a simple online form be used on the Department website to get the overall process re-started?

The questions above are directed at members who would be willing to submit (and in many cases re-submit) information. In addition, webmasters need to inform Monument Officers about what processes (e.g. free form builders such as Zoho or HubSpot) would be practical for entering the essential data.

The Department of New York GRO position had been vacant for approximately two years when I was appointed about two thirds of the way into 2018. Perhaps the prime mission of our Order is identifying a veteran, finding his grave, registering it into the National Database, and ensuring that the grave has a proper monument. I became interested in this work when, in the Summer of 2018, I started to research the graves of Civil War veterans in the cemeteries of the Town of Edinburg in western Saratoga County where my family vacations. This work led to questions which I asked of the National GRO who logically pointed out the vacancy in the Department of New York. So, when no experienced brother could be found to volunteer, and knowing well that the best way to learn is by doing, I volunteered.

I then compiled a list of the Camp GROs in New York or, if there was none, substituted that Camp's Commander and, using the list, introduced myself, offering to help. It seemed odd that the Department Bylaws provided annual awards for the camp/brother who registered the most graves but no recognition for those who obtained and arranged for the installation of monuments (headstones) obtained from the Veterans Administration. I wrote to the list that I intended to ask that the Department Bylaws be amended to provide such recognition and to clarify the wording about the existing graves registration awards. The later was endorsed by the midyear meeting at Ithaca. Both proposals will be considered at the upcoming 136<sup>th</sup> Encampment.

Presenting awards based on numbers means one needs the numbers so I asked the National GRO if I could get reports by camp and individual showing the numbers of graves registered by time periods. Brother Bruce Frail told me he was concerned that a focus on numbers would lead to a diminution in quality and the work should not become a competition of camp vs camp and department vs department. I have also learned that some who have done many registrations want no recognition (doing the work is their satisfaction) while the Banner has published articles honoring others who have done much.

In early March, I again used the e-mail list to ask the camp GROs to submit the numbers of graves registered by those of their members who did such work and a total for each camp so the

Department Awards, one to a brother and one to a camp, could be made. A copy of the suggested report is attached. As yet, I have received no responses.

Curious about what other departments do in this regard I looked at the bylaws of about a dozen departments and found only 2 that mention awards at all in their bylaws (this topic must be covered elsewhere) and while one has a graves registration award it does not specifically mention number of graves registered.

I was asked to audit some entries to the National Data Base made by members of my own camp and found many duplicates, some triplicates and worse, and an absence in many records of grave numbers and readily accessible information about many veterans' service, an experience which supports the National GRO's concern about quality first. I was able to do this because our Camp GRO had an old list of all the Data Base entries for the Town of Hempstead's Greenfield Cemetery. The full report is attached.

Recently, a fellow named Bob Farrell from Huntington, L.I. who is not a member of the SUVCW presented the Moses A. Baldwin Camp #544 with a list of almost 6,000 Civil War veterans including the Cemetery name for about 10-15% of these. By my estimation, this is probably just about every veteran from Long Island except for those who were living Brooklyn. We will be working on getting these into the National Database. So far, I have one volunteer, William M. Devine, Jr., a brother inducted just last month. Bob Farrell has long been active in the Town of Huntington Historical Society is well known on Long Island as a Civil War researcher and author of *Our Veterans Brave and Noble*.

I now have an "administration account" which permits me to make corrections to existing records and to delete verified duplicates. "Submitter Accounts" permit the holder to enter additions to the database which are then actually added after review by a "submitters' assistant," a step which was added after it had been observed that quality needed to be enhanced. Anyone who has corrections or additions such as a recently discovered grave location, or additional information about a soldier's service can contact me at <a href="duffy9999@aol.com">duffy9999@aol.com</a>. ### Recommendations:

- 1. Make no Department of New York Awards for 2018 due to lack of information.
- Take advantage of the Commander–In-Chief's presence at our Encampment to have a
  discussion about competition/quality/completeness/awards or not and what
  information/reports might be made available from the National Database to facilitate the
  work.
- Initiate a discussion (put this on the agenda) at the Lake George Encampment among the delegates to find out what is happening at the camps and to determine/initiate future action.
- 4. See attached recommendations to the National GRO in the attached report.

RE: National Graves Registration Database.

I just completed a review of the records of 15 Union veterans in the National Database which had been added over the years by members of the Moses A. Baldwin Camp #544, the Camp of which I am Secretary-Treasurer. My review was prompted when our Camp GRO, Joe Hervan, gave me a list for Greenfield Cemetery, Uniondale, New York which he had received a couple of years ago and which showed 113 entries. Bro. Joe had noted that 14 appeared to be duplicates. He asked me to check into these and use my administration account to make any necessary corrections. I added a 15<sup>th</sup> name as when looking at the records for William H. Raynor, I saw that Elijah K. Raynor appeared to have duplicates also.

### **OBSERVATIONS:**

- 1. All 15 were indeed duplicates. Several were triplicates and there was one quadruplicate.
- 2. Many of the records were completed in all Capitals which I understand is frowned upon.
- 3. Many had no grave # but Greenfield Cemetery easily provided it.
- 4. When I searched on surname "Raynor" I got back a page that said 1-35 of 35 (should be 46) entries. When I went to page 2 it said 36-46 of 11 (should be 46) entries.

ACTION: All the errors outlined in OBSERVATIONS, above (except for #4) were corrected and, in addition, I added additional information for many of the veterans such as presence on Find-A-Grave, information from the NY Adjutant General's Reports, if a pension was approved based on the veteran's service, and, if so, to whom it was paid. A total of 19 records were deleted and each of the remaining 15 were updated with additional information.

### QUESTIONS:

- 1. When adding records, should I use my submitter account or my administration account?
- 2. How do we handle burials at sea? Should these go into the database with that notation and, if known, the name of the vessel and location at time of the "burial?"
- 3. Do we record deaths on battlefields or at the prison camps where there were mass burials?

### **RECOMMENDATIONS:**

- 1. Display the name of person who entered the record & date of entry.
- 2. Display the name of the latest person to correct the record and date of correction.
- 3. Autofill is more a bother than it's worth.
- 4. Expand "Age" on the screen to "Age @ Death."
- 5. Correct the numbering shown at the bottom of the pages returned by a search as noted in OBSERVATIONS, above.

Commander,

I have had the honor to fill the position of NY SUV Archivist for the last 3 years. Much has been done, as past reports have elucidated. The last year has seen little activity.

For this past year I have continued to maintain the assorted archival material in a dry, temperature controlled environment and the remaining boxes of items are secure.

I did sell many GAR type badges and received a price of \$1,300 for the items, fairly appraised and purchased by the foremost authority on GAR ephemera.

A series of files was turned over to Mr. Albanese concerning some legal action against a past commander (I believe). Those files have not been returned.

I also loaned some papers to Mr. J. Orton, and he is still in possession of those files.

The archival account at the Adirondack Trust Co has balance of \$1,981. Tim Mabee and I are co-signatories on the account, requiring both to sign for any check drawn on the account. Nothing has been withdrawn over the last 24 months and only the deposit for the GAR badges has been made.

There are a few other non NY items in the collection, one being the badly damaged Naval Cutlass and the other being a haversack type

shoulder bag from a Wisconsin Regiment. These items should and will be sold and the proceeds added to the archival account.

Mr. Albanese did request to be added to the account and all the necessary bank paperwork was forwarded to him, but was not completed nor returned.

If asked by the incoming Commander, I would remain as the NY Archivist. At this juncture, all items are well cared for and I will continue to retain all the NY SUV items if I am to remain as archivist.

### 2018 - 2019 Report of the Department Webmaster Raymond W. LeMay, III, PDC

Commander McGuire, Fellow Officers of the Department, Brethren,

May my report please the 136th New York Department encampment.

First and foremost, I want to recognize my predecessor Brother Robert "Bob" M. Paul, PCC in maintaining the old department website all of these years and continuing to do so for a good portion of this year while I was working to move the site to a new platform. It was not until I got into it that I fully recognized just how much he had done.

I have previously served the Department as Backup Webmaster and as Webmaster of my camp the Col. George L. Willard Camp No.154 of Albany and to have this opportunity to serve has been an honor.

In the past, our website was hosted through the National organization of the Sons Of Union Veterans of the Civil War (which I have been informed that the Department has never been billed for). While this was satisfactory at the time, that platform holds with it many limitations that I wished to address such as making the site adapt its appearance to better fit mobile devices such as tablets and cell phones.

Therefore, it was decided to move the website and rebuild it using wordpress on its own hosting with its own domain name. The domain name that was selected by Commander McGuire was <a href="nysuvcw.org">nysuvcw.org</a> which I registered with GoDaddy on 9/13/2018 at the promotional price of \$9.17 on an annual basis running to 9/13/2019. I then registered with 1&1 Internet for our annual hosting package on 10/5/2018 to 10/5/2019 at the promotional cost of \$11.88. The hosting plan that was selected was 1&1 Managed WP Basic. I also registered us with free accounts on google analytics to keep track of stats and mailchimp for emails for the Department website mailing list.

I started my work by backing up the Department website and then choosing and formatting a new design Wordpress theme, which I purchased as my personal donation for the new Department website.

I then began re-building the new website on the wordpress platform by transferring and updating the site's pages, updating all the links. There are currently over 100 pages. The new Department website went live on the 5th of February 2019 and was vetted and announced to the brethren via Department Order #9.

The new features that are available with the current website are a cleaner more interactive design with drop down menus, social media integration with our facebook account feed, mobile responsiveness, interactive contact forms and links, department events calendar, mailing list subscription and database. We also have a customizable brothers only section for brothers who can register and customize their own profile account on the login page and upon my review they are approved and can gain access. There is contact information for Camp

Officers posted under that section as well as a limited beta version of a graves/monuments registration submittal form with the option to upload one image.

According to Google Analytics, the site has received 3581 unique pageviews since its release. Also of note, already 28% of our traffic is coming from cell phones and tablets.

The website is by no means finished (it is an ongoing project). The Ellis Camp website is still under construction and the various Graves and Monuments that have been submitted to me and that were on the old Department website are yet to be added. I am currently testing a graves/monuments form which will automatically create a webpage upon my review of a grave/monument submission.

### PROPOSED BUDGET FOR THE DEPARTMENT WEBSITE FOR 2019-2020:

- GoDaddy: NYSUVCW.org domain name from 9/13/2019-9/13/2020 = \$21.17
- 1&1IONOS Website Hosting for from 10/5/2019-10/5/2020 = \$95.88
- Total: \$117.05 for 2019-2020 year
  - \*Note: Hosting costs may change as 1&1 Internet was recently acquired by IONOS\*

### SOCIAL MEDIA:

We continue to maintain a presence on social media with Facebook. I work hand in hand with Brother Jeff Albanese, PDC in maintaining the Department Facebook page. Jeff does a great job posting topical posts that keep the page active. I focus on posting about our organization's activities.

Our Facebook community page keeps continuing to grow. There are currently 731 likes, a growth of 34 from May 1, 2018 to May 1, 2019. We currently average 54 reaches a day total with our posts (a "reach" is a how many people see some piece of our content, whether or not they have liked the page).

### 2019 DEPARTMENT WEBSITE AWARD

Last but not least, the 2019 New York Department Website Award is hereby awarded to the Moses A. Baldwin Camp No.544 of Hempstead, Long Island. Brother Mike Duffy camp webmaster has gone above and beyond in maintaining their camp website.

### PROPOSALS/RECOMMENDATIONS:

- I believe that the process of submitting graves/monuments needs to be discussed in order to make what we are doing more in accordance with the Civil War Monument Assessment Form #61, specifically with focusing on the form data rather than the images.
- That a donation box/button be placed on the Department website to claim donations from Brothers/Sisters/Public etc for the Department as a fundraiser and that an online pay/payment option be set up for that purpose.
- 3. An online payment option be placed on the Department website for encampment registrations and banquet registrations by brothers/sisters via paypal or another form of payment that would streamline registrations. If there are any fees involved they would be passed along as a "convenience fee" to the payer. Obviously this would not be the only option, but it may appeal to some members and help streamline the process.
- 4. Once 501c3 status is achieved as a non-profit we should apply to Facebook to be added as a Nonprofit, add a Fundraiser button to our Facebook page which would accept donations directly from the public. This would allow us and people to set up fundraisers "campaigns" in which the money would be sent to us and we would be allowed to receive donations via Facebook such as Facebook's birthday donations.
