Your Camp should be electing delegates for the Encampment. This is how you can determine your number of delegates. Per Regulations, Chapter II, Article II, Section 1 (a). All PCinC, PDC, PCC, sitting Dept Commander, sitting Camp Commanders are automatically Delegates. Each Camp gets one delegate, plus one for every ten brothers or major fraction thereof. Any Camp Treasurer or Camp Secretary who has served for ten years is given the rank of PCC with voting privileges. When you send in your

registration you can include your delegate card or bring it with you. Also, you will need your current membership card. The Encampment is always an enjoyable time and a great opportunity to visit with old friends and make new ones.

At this Encampment we will be electing a Dept Commander, Sr Vice Commander, Jr Vice Commander and three Council Members. Typically, the Sr Vice will move up to Dept. Preservation of the NYS Battle Flags

Brother O'Brien started off running as the Chairman for the NY Department Fundraising Committee. With the support of Brother Albanese, Brother Stump, and Brother LeMay III the PayPal link was posted on our website to start the fundraising efforts. Within days \$20 for the Battle Flags and \$22 for the department general fund was submitted through PayPal. A modest start but a start indeed. PayPal will only work if we promote the website and donate for our cause.

The Fundraising page was posted on the website to bring more attention to our efforts to raise funds. That is when Brother George McGraw contacted Brother O'Brien to inform him of his donation to the NYS Museum to preserve two Battle Flags of the 111th. Brother McGraw lives in Texas but is a member of Sgt Judson Hicks Camp #111 in the Department of New York. Brother McGraw donated \$20,000 for the preservation of these two battle flags. Brother McGraw did this to honor his Great Grandfather Isaac Mullie who served in the 111th NY Infantry Company D. Isaac at the age of 20 enlisted 5 August 1862 at Williamson. Private Mullie in an engagement at Sutherland Station, VA was wounded in action. He was discharged for

disability on 13 May 1865. Thank you, Brother McGraw, for honoring your Great Grandfather Isaac Mullie and the Boys in Blue.

The Baldwin Camp raised separate from the fundraising committee \$500. But due to Brother George McGraw through the fundraising committee, he matched Baldwin camp raising it to \$1,000 to preserve the battle flags. Great job Baldwin Camp and Brother McGraw. Keep the great work up.

To date the fundraising committee has raised, with the help of Brother McGraw and Brother Duffy \$21,020 as of 22 February 2023. Not bad for just starting.

Brother George McGraw is putting up an additional \$9,500 dollars to match any camp and department fundraising for the battle flags. Brothers, please take up the gracious offer by Brother McGraw.

Brother O'Brien, knowing this wasn't enough, engaged Hon. Richard Dollinger retired to help our effort. This man of experience volunteer to assist our fundraising committee to raise the funds required to preserve the rest of the battle flags. This effort requires setting up a separate account to save and build the funds at minimum to \$2,500,000 to pursue a matching grant from NYS. However, Hon. Richard Dollinger agreed with Brother Dennis Duffy that the legislatures should honor their obligation to fund and preserve the battle flags. Brother Duffy and Hon. Dollinger are working together to pursue

this avenue first before we launch a massive fundraising effort for the battle flags. Hon. Dollinger stated that we may be too late for this budget cycle but can mount an aggressive grassroot operation in April on. This will require a large contingent of Department officers to show up in Albany when brother Duffy and Hon. Dollinger coordinate and inform us of the date and time. Hon. Dollinger recommended taking high resolution pictures of the battle flags by the museum for fundraising purposes. Brother Duffy is confirming with the museum to see if this was already accomplished and if we could use those pictures to raise funds.

The fundraising effort will require massive support within our department. Brother O'Brien found volunteers to reprise the Rally Around the Flag Committee which will serve as a sub-committee to the department fundraising committee. With volunteers on both committees, the NY Department can now aggressively raise and work on the preservation of the battle flags. The fundraising committee is currently reaching out to 16 Veteran Organizations to form a coalition in lobbying for the funding of the battle flags. Those that respond positively to our request; we will also request their help in raising funds. Every little bit of funds we raise gets us closer to our end state.

It is my firm belief that Brother O'Brien leadership is taking the fundraising

committee in the right direction to accomplish our goals. We ask that every brother in the NY Department help support this huge endeavor. With all of us working as a team we will be successful, not only in this effort, but in all our other projects as well.

Marker Dedication

The City of Niagara Falls, NY will be hosting the dedication of a historical marker at the Amtrak Station in Niagara Falls, NY on Saturday, May 20, 2023 at noon. The marker commemorates the arrest of two Confederate saboteurs who were arrested before they could escape back to Canada by train. They were arrested at the former train station at Niagara City – also known as Suspension Bridge – in December of 1864 by a local policeman. The marker was funded by the William G. Pomeroy Foundation through a grant application made by the Niagara Frontier Chapter of the National Railway Historical Society.

I will advise if the dedication is rescheduled.



One Country and One Flag

In 1899, S. B. Kemp Post #108 of the G.A.R. erected a memorial in the resort hamlet of Olcott in the town of Newfane, Niagara County. It was a bustling place at the turn of that century, on the shore of Lake Ontario. Originally erected in the center of an intersection, the monument suffered from being struck by cars as those vehicles became commonplace. The monument was periodically repaired in

places and was eventually moved out of the intersection and onto a median. In 2018 the monument was removed, expertly restored, and returned to its position in Olcott. A half-hour video about the memorial and its restoration is on YouTube: The Olcott Civil War Memorial Restoration - YouTube

The monument is adorned with just over 70 *incomplete* names of Civil War soldiers and sailors. As a New National Graves Officer, I decided to try to complete the identity of the names on the monument, find the basics of their service records, and find and register their graves in the SUVCW graves database. Overall, I spent two months on this project. Some names were especially difficult to complete and match in the Find-a-Grave website.

For example, J. JEFFREY is on the monument. I was able to determine that this was Jackson JEFFERY (different spelling) through his muster roll abstract. Looking for his grave, I kept coming up with nothing, hour after hour, day after day, until I found his true name in a desperately wide search: Andrew Jackson JEFFERY. I'll remember that the next time I find Jackson as an alleged first name.

I found 57 graves matching names on the memorial. Some graves were not found; some names were of soldiers buried anonymously on the fields where they fell. In 2015 I posted this monument, called "One County and One Flag," online in the Historical Marker Database (HMdb.org) and

updated it with 2019 images of the restored panels with now legible *incomplete* names.



This year I added these remarks to the page in the Historical Marker Database:

"For each of the names on this memorial, I provide the Find-a-Grave ID below, if found.

"All who have an individually identified grave have been registered online with the Sons of Union Veterans of the Civil War (SUVCW.org) with their service information.

"For each name without a grave, I provide a brief description, however, duplicates are skipped, as are those not honorably discharged.

"I proceed as they appear on the memorial. Please advise of additions & errors.

I created a three-part circle of data for each grave matching a name on the monument.

1) For each SUVCW grave registration with a matching name on this G.A.R. monument, I made a notation of it in the SUVCW registration entry along with the Find-a-Grave memorial ID. 2) For each Find-a-Grave memorial ID matching a name on this G.A.R. memorial, I left a G.A.R. "flower" noting that the grave is registered in the SUVCW graves database. 3) On the HMdb.org page for this G.A.R. monument, I matched the Find-a-Grave memorial ID with names as explained above.

The 151st NY and the 8th NY Heavy Artillery are well represented on this monument, among others."

Authorization of Grant's posthumous promotion to the army's highest rank becomes law

The Grant Monument Association is pleased to report that Congress has passed, and today President Biden signed into law, legislation authorizing the President to posthumously promote Ulysses S. Grant to General of the Armies of the United States. the U.S. Army's highest rank. This provision was passed as Section 583 of the National Defense Authorization Act, which is accessible here. It confers on Grant the same rank and precedence held by General John J. Pershing, the only officer to have been General of the Armies of the United States during his lifetime. The posthumous honor of that rank was conferred in 1976 upon George Washington during the celebration of the nation's bicentennial. This posthumous promotion of General Grant is a fitting honor in this bicentennial year of his birth. It reflects the extraordinary importance of his military career. Washington and Grant were the top commanders of the U.S. Army during the two wars of existential importance to the United States: the Revolutionary War and the Civil War. Grant, whose battlefield achievements ensured the survival of our nation amid the greatest threat it had ever faced, is regarded by many military historians as the most capable and

accomplished general in American history, besides being one of the great military commanders in world history. His campaigns are still studied by the modern U.S. Army. Beyond that, his battlefield accomplishments effected the emancipation of enslaved people, and during his postwar career, he fought for profound changes to the Constitution that conferred upon former slaves equal rights, including the right to vote regardless of race. This singular record of accomplishment should stand as an inspiration to Americans for generations to come. Special thanks to the cosponsors of the original legislation authorizing Grant's posthumous promotion (see links for House cosponsors and Senate cosponsors), without whose support this honor would not have been conferred. They're looking for caterers to do their functions. Once they have that locked down we can get a cost for the lunch and banquet.

Lunch is a minimum of 15 people. The banquet will depend on the new caterer.

After the Encampment our committee will need to tighten the details and costs.

We will need to work 2025 department encampment which the DUVCW will work the contract. The next rotation is in the northeastern region.

The northeastern region essentially includes the upper northeastern quarter of the state including the upper Hudson and currently includes four camps the Willard, Tanner, Searle and French Camps (117 total members in region.) There have been about five encampments in that region since 2003 three of which since 2011, one in the Albany suburbs, one in Saratoga, and one in Lake George.

As brainstormed on encampment options to keep costs down we'll be using second tier locations for Friday through Saturday meetings and banquet. Second tier meaning a place like the American Legion, colleges, elks club, etc. That can provide 3 meeting rooms, possibly lunch and banquet, located near a hotel.

126thNY SVR Drill at the Letchworth Battle Event

The 126thNY SVR will be having its first hands-on drill on Saturday, May 20 at 11:00, in conjunction with the Letchworth Battle Event. Members are encouraged to wear Federal uniform and battle kit, if you have it. We will be practicing basic Hardee's manual of arms, loading and firing, with limited marching and movement, based on weather, turnout, etc. There will be NO battle drilling or field work as the 126thNYSVR will be solely a ceremonial unit for now.

The event's full Infantry Drill is scheduled for 10:00, before ours. Per standard reenacting rules you must register as a reenactor and attend the 10:00am drill if you wish to participate in the actual battle.

For the 126th's drill, meet at 11:00am at the south end of the parking lot in the Upper Rec Area, just a mile in from the Mt. Morris entrance to the Park.

You will have to stop at a Park Entrance and possibly pay the entrance fee. They generally let re-enactors through if they are in uniform.

NEW YORK CIVIL WAR OFFICER WAS AN ACCOMPLISHED ENGINEER, by

Engineers and railroaders made up a sizable group of Civil War officers who served from New York State. Likely one of the largest stemmed from those who received their professional educations at such institutions West Point on the Hudson River, and to a much lesser extent Norwich University over in Vermont. Still others came up through the "school of hard knocks," learning their professions from private tutelage, experience and taking advantage of "windows of opportunity." Among them were Col. Daniel C. McCallum, who shared heading of the U.S. Military Railroads with Col. Herman Haupt for a time, and Col. Julius Walker Adams, who was an organizer of the 67th NY Infantry.

In his pre-war career, Adams was credited with designing the New York & Erie Railroad's Cascade Bridge, on the grade between Lanesboro, PA and Gulf Summit, NY in the late 1840s. The timber structure, one of very few of its kind, spanned a deep (185 feet) gorge over a length of nearly 200 feet where waters from the surrounding hillsides poured down into a tributary to the Susquehanna River near the NY/PA line. Adams was again heralded with completing design of another major Erie

project, the Starrucca Viaduct, at Lanesboro. It became known as THE BRIDGE OF STONE. Major features were seventeen arches, an average height of about 90 feet above the floor of the valley of Starrucca Creek, and a top width to accommodate double-tracking of the (then) 6-foot gage Erie. Adams had already gone on to other engineering projects when the railroad was frantically looking for another engineer to bring the structure's construction to completion before the portion of the line to Binghamton Road was due to open in December, 1848. He contacted his good friend (and distant relative) James P. Kirkwood, who ably took over supervision of the viaduct's building and saw it through to successful completion. The line was opened to Binghamton as scheduled, and the lives of the two engineers went on.

When the Civil War broke out, Julius W. Adams was an engineer lieutenant in the 4th U.S. Infantry. He was handy when the 67th NY Infantry organized at Brooklyn, NY in June, 1861, and as of the 24th became its Colonel. His service included campaigns and battles such as Yorktown, Seven Pines, the Seven Days and Antietam. He changed hats in late October of 1862, serving briefly in organizing the Second Hawkins Zouaves, a 9-month regiment, and helped lay foundations for what became the 178th NY Infantry. He briefly oversaw consolidation of the Zouaves with the 3rd Merchants

Brigade to form the Blair Rifles. The term of service was extended to three years. By summer of '63 he had resigned from active duty, but lent a hand to help set up shelters around Brooklyn for people caught up in the intense violence of the July, 1863 NY Draft Riots.

Both military alumnus Adams and civilian Kirkwood went on to distinguish themselves in the civil engineering profession, and both served in key roles as members of the American Society of Civil Engineers (ASCE).

A lot on Adams's career can be found in STARRUCCA, THE BRIDGE OF STONE, with first printings authored in the 1970s and 1980s by local writer William S. Young. Recently, the Susquehanna County Historical Society at Montrose, PA has launched another reprinting of the work, as supplies of older versions have fast become exhausted. Brothers interested in such engineering aspects of the Civil War may find it interesting to secure a copy; reprinting is expected to be done by Fall, 2023 and seekers of the new edition can use key words to access the Society's web site.


Betty J. Baker, age 78, passed away on Saturday, January 21, 2023 at FF Thompson Hospital, after a hard fight with cancer.


CAMP MOURNS LOSS OF DANIEL OLSON

For nearly 30 years, Brother Olson was one of the most active members of the Camp, serving for more than a decade on the Camp Council, as well as Secretary-Treasurer in 2001, and for several terms as Senior Vice Commander, most recently from 2020 until his death. For many years Brother Olson organized the extensive Memorial Day and Veterans' Day events in Lyons.

After his graduation from college, Dan Olson served in West Africa in the Peace Corps as a Professor of Agriculture. After his return he taught high school while working the familyfarm. Upon his retirement from Victor Central High School, he taught at Alfred University as an adjunct professor. Dan was active in politics at the local, county, and state levels, as well as in several community organizations.

Dan's father, Herbert V. Olson, a WWII veteran, was a member of the Camp, and Dan's son, Erik Olson, joined in 1998 as the Camp's first Junior Member. In addition to Erik, Jay and Steve Olson are current members of the Camp.
